The process under chapter 82, Wis. Stats to lay out a highway in the town described as follows is hereby initiated: a 333 foot extension of Titus Drive extending south from the current terminus of Titus Drive to a point which approximates the south line of Black Sheep Trail, all of which is located in the NW, SE, Section 10, T39N, R6E. (More specifically described in the attached description.)
